# EMPIRE CLASSIC Exhibitor Rules and Regulations 2010

**Codes and Agreements** - Exhibitor agrees to be bound by the Rules and Regulations of the event. Exhibitor further agrees to adhere and be bound to (1) all applicable fire, utility, and building codes and regulations of the government agencies with jurisdiction in the event site; (2) rules and regulations of the facility where the event is held; (3) the terms of leases and agreements between Millennium Fitness Productions and managers/owners of said facility; and (4) all the terms of any and all leases and agreements between Millennium Fitness Productions and other party relating to the event.

**Space assignments** - Assignment is strictly a first-come, first-serve basis. Proper payment of booth fees must accompany contract. Millennium Fitness Productions reserves the right to make changes in booth assignments and the floor plan without approval of the exhibitor. Booth space is approximately 8 feet wide and 6 feet deep. IAll booths are provided with two (2) chairs and one 6' table. **Exhibitors who may require additional space for their displays must register for additional tables.**

**Registration Deadlines** - Registration deadline is **April 10<sup>th</sup>, 2010**. Booth registration amount is \$500.00. Any vendor registering after April 10<sup>th</sup>, 2010 must include a \$50.00 late fee for a total registration cost of \$550.00. ***Exhibitors not paid in full prior to the exhibit date will not be allowed to participate in the vendor exhibit.***

**Sponsor Logos** – Company logos for all sponsors will be included at no additional charge on contest t-shirts as well as the show website, [www.spokanebodybuilding.com](http://www.spokanebodybuilding.com). Logos must be submitted by March 1, 2010 to be included on contest t-shirts. Logos can be e-mailed to [spokanebodybuilding@gmail.com](mailto:spokanebodybuilding@gmail.com) and must be 300dpi minimum resolution. Any logos not meeting the deadline or resolution requirements will not be included.

**Program Ads** – Program ads are 1 full page (8.5x11), printed black and white. Ads submitted may be resized as necessary to accommodate printing and binding margins. Ads must be received by April 10<sup>th</sup>, 2010 and can be e-mailed to [spokanebodybuilding@gmail.com](mailto:spokanebodybuilding@gmail.com) or mailed on CD to the address above. PDF format is preferred.

**On Stage Banners** - Exhibitors who wish to display banners on stage must have the banner delivered by April 17<sup>th</sup>, 2010. Maximum banner size is 3x6 feet unless otherwise approved by Millennium Fitness Productions. Banners will hang on the stage backdrop, directly behind competitors for optimal exposure. Placement and arrangement of banners is at the sole discretion of Millennium Fitness Productions. A pre-paid shipping label and shipping tube MUST accompany any banners or signs that are to be returned to the vendor after the event.

**\*\*\*\* Ads or banners submitted after their respective deadlines may be excluded from the event. \*\*\*\***

**Cancellation and Refunds** - Exhibitors shall have the right to cancel this agreement at any time by written notice to the Millennium Fitness Productions. In the event of such cancellation the following terms shall apply:

1. Cancellations prior to April 10<sup>th</sup>, 2010, \$100 cancellation fee subtracted from any amount paid.
2. Cancellations made after April 10<sup>th</sup>, 2010 will not be refunded.
3. Upon notice of cancellation, Millennium Fitness Productions reserves the right to resell the vacated space.

**Assignment/Sublease** - Exhibitor shall not sublet the booth or any equipment provided by Millennium Fitness Productions nor assign the booth in whole or part without written permission of Millennium Fitness Productions.

## **Security/Liabilities/Insurance**

(A) Millennium Fitness Productions will insure the host site secures the exhibiting area during non-exhibiting hours. After show hours, only those exhibitors properly identified with a vendor pass may enter the exhibit area.

(B) Neither Millennium Fitness Productions nor the exhibit facility, their members nor their representatives, and/or employees thereof will be responsible for injury, loss or damage that may occur to the exhibitor, or the exhibitor's employees or property for any causes whatsoever prior, during, or subsequent of the period covered by this application/contract.

(C) Millennium Fitness Productions will not be liable for failure to hold the event as scheduled. Payments for exhibit space will be returned in that event. Any actual expenses incurred in connection with the event will be deducted if it is cancelled ninety (90) days or less prior to the scheduled date because of fire, or any act of God, or the public enemy, or strike, or any law, or regulation, or public authority, which makes it impossible or impractical to hold the event.

(D) Exhibitors agree to maintain such insurance that will fully protect Millennium Fitness Productions, the event management and Northern Quest Casino from any and all claims of any nature whatsoever including claims under the Workman's Compensation Act, and for personal injury, including death which may arise in connection with the installation, operation, or dismantling of the exhibitor's display.

(E) Damage to inadequately packed property is the exhibitor's own responsibility.

(F) Damage to the facility housing the event, caused or done by the exhibitor shall be replaced or repaired by the exhibitor. Additionally, the exhibitor agrees to protect, save and hold harmless Millennium Fitness Productions and the Northern Quest Casino, or any part thereof, directly or indirectly.

(G) Exhibitors are advised to add on their existing insurance a portal-to-portal rider at minimal cost, protecting them against loss/damages of their material by fire, theft, accident, etc.

**Admissions** - Millennium Fitness Productions shall have sole control over all admissions of persons into the event. All persons visiting the Empire Classic will be admitted according to the rules and regulations of the event. ***Each exhibitor will receive 2 vendor passes to the event unless otherwise agreed upon with Millennium Fitness Productions.*** Any person not presenting a vendor pass or a ticket will not be admitted to the event area.

**Amendment to Regulations** - Any and all matters and questions not specifically covered by the articles in this contract shall be subject to the decision of Millennium Fitness Productions. The aforementioned items covered by this contract may be amended at any time by the management in interest of the event and notice thereof shall be binding on exhibitors equally with the forgoing rules set forth in time.

**The event area will be open Saturday April 24<sup>th</sup> from 7:30AM to 9:00AM for setup. The pre-judging event will take place from 9:30AM until approximately 1:00PM. The Northern Quest Casino auditorium will be closed to the public from 12:00PM until 5:00PM. Exhibitors should be back at their booths by 5:00PM, when the doors open to the public. The official start time for the evening show is 6PM and will be finished by 10:00PM.**
